**Abstract**

Public Works Department - Amendment to Rules for Reservation and Occupation of Rest Houses, Camp Sheds and Conference Halls under Public Works Department - Orders issued.

**ORDER**

As per Government Order read as 2<sup>nd</sup> paper above, Government issued Rules for Reservation and Occupation of Rest Houses, Camp Sheds and Conference Halls under Public Works Department. As per Rule 5.10.1 to the Rules, Members of the Parliament and Members of the Legislative Assembly of Kerala State are eligible for the same concessions which are allowed to Grade I Government officers in the matter of occupation of room in a Rest House. As per Government order read as 1<sup>st</sup> paper above, rates of room rent at Government Guest Houses are fixed for various concessional categories and the corresponding rate of room rent payable by Members of the Parliament and Members of the Legislative Assembly is Rs.50/- + Air Condition Charges if any @ of Rs. 25/- per day.

2. Government have now decided to amend Rule 5.10.1 of the Rules for Reservation and Occupation of Rest Houses, Camp Sheds and Conference Halls under Public Works Department and to limit the rent of rooms at PWD Rest houses accommodated by Members of the Parliament and Members of the Legislative Assembly of Kerala State at the rate of rent fixed for Members of the Parliament and Members of the Legislative Assembly in Government Guest Houses, ie., Rs.50/- + Air Condition charges if any @ of Rs. 25/- per day..

3. The revised rates shall be deemed to have come into force w.e.f 25.05.2016. The Chief Engineer, Public Works Department, Buildings and all concerned Executive Engineers shall take necessary steps to reimburse the excess amount, in excess to the revised rates, received from Members of the Parliament and Members of the Legislative Assembly of Kerala State w.e.f 25.05.2016.
